MGSA Goals and Activities

The Modern Greek Studies Association was founded in 1968 by a group of intellectuals and scholars (Americans and Greeks in America), to showcase the merits of the modern Greek tradition and contemporary Greek culture. It has evolved since then to an American-based, non-profit academic organization, dedicated to the promotion of Modern Greek Studies in the United States and Canada and conversant internationally on all issues, historical and contemporary, which pertain to Greek matters.

Interdisciplinary in orientation, the MGSA seeks to stimulate the discovery and diffusion of knowledge about the language, literature, arts, history, politics, economy, and society of modern Greece, Cyprus, and the Greek diaspora. Its membership, which currently exceeds three hundred, consists primarily of teachers, students, and professional scholars, many of whom reside in various parts of the world, including Greece. Membership also includes and is open to many other individuals who are actively concerned with Greek history and culture, even if they are not necessarily academics.

The MGSA defines its scope broadly to include not only post-independence Greece but also the period of Ottoman rule and the later Byzantine Empire, as well as those aspects of early Byzantine, Hellenistic, and Classical times that have a bearing on the modern period. The impetus is not to reinforce the continuity thesis but to show how multifaceted Greek history and culture are.

It is this same investment in the broad range and multifaceted character of Greek history and culture that underlies the MGSA's commitment to an interdisciplinary approach to all things Greek. This includes an explicit commitment to engage questions emerging from Greek diaspora conditions and the Greek-American experience.

The MGSA's activities since its foundation have been and continue to be extensive. The Association convenes a biennial Symposium, which has steadily grown in size, reputation, scholarly range, and international participation. The first Symposium took place at Princeton University in 1969. Recent Symposia have also featured an Awards Ceremony at which the various MGSA Prizes are presented (such as the Edmund Keeley Book Prize, the Elizabeth Constantinides Memorial Translation Prize, etc.). The MGSA's publication activities include the most reputable periodical in the field, the *Journal of Modern Greek Studies*, published by The Johns Hopkins University Press, a Bulletin distributed electronically to its membership, and over the years, a number of significant volumes on Greek history and literature. The MGSA also serves as an information and communications center for all persons seriously interested in the study of modern Greece and Cyprus through its website information and the listsery, MGSA-L.

The MGSA held its very successful **23rd Symposium** at Indiana University in Bloomington, Indiana, from 14-16 November 2013. This Symposium was hosted by Franklin Hess (Indiana University), Chair of the Local Arrangements Committee, and Artemis Leontis (University of Michigan), who served as Chair of the Program Committee. Program highlights included the truly interdisciplinary work presented by junior scholars, the keynote address delivered by Yanis Varoufakis before more than 250 attendees, and the evening dedicated to "Greece in Writing," which brought together young creative writers and senior scholars. MGSA Fund for Innovative Initiatives

The Fund for Innovative Initiatives in Modern Greek Studies provides monetary support to institutions of higher learning and other professional organizations to support conferences, workshops, and other related activities that promote Modern Greek Studies (including studies of the Greek diaspora). Granted on a competitive basis, up to five grants will be awarded annually, each for a maximum award of \$500.

The MGSA regularly updates its directory of Modern Greek Studies Programs in the United States and Canada. If you have not yet had a chance to list your program or to update your program's profile, please contact us at mgsa.org@gmail.com and we can help you with the process. If you are working to establish a new program or know of such an effort, please do not hesitate to seek the MGSA's advice. Updates of and additions to faculty and graduate student profiles are always welcome as well. Currently the MGSA's program directory lists more than 50 programs.

The program listings in the MGSA directory provide detailed information on the following: the individual program's college or university affiliation and geographical location; contact persons and teaching personnel; departmental websites, email addresses and telephone numbers; lists of faculty teaching Modern Greek language, literary and cultural studies, anthropology, history, political science, and/or courses in other fields related to Modern Greek Studies (often with approximate enrollment numbers); regularly taught graduate courses (and/or names of graduate students); study abroad options; program resources, achievements, and challenges; recent initiatives in curriculum development, collaborative projects, and outreach efforts; initiatives focused on increasing educational and research support, etc.

In the current crisis of the Humanities and of modern language instruction in general, many programs have seen their personnel numbers and student enrollment numbers decline. However, many have also successfully warded off the most threatening challenges by seeking new, cross-disciplinary collaborations across departments, campuses, and even across state and national borders.

Whether you are an aspiring graduate student, faculty, or an administrator or potential donor seeking information about the offerings and qualities of different Programs, we recommend that you look carefully at the MGSA Directories pages on Programs, Faculty, and Graduate Students. We strive to keep these pages up to date, with the help of our members.

JMGS: A Call for Special Issues

The **Journal of Modern Greek Studies** is a peer-reviewed journal published twice a year as a service to MGSA members, who are encouraged to submit their work. The co-editors, Professors Artemis Leontis and Neni Panourgia, are inviting scholars in the field to submit proposals for interdisciplinary special issues. Applicants are welcome to propose a topic accompanied by an abstract, which will frame its subject, explain its importance, name the coordinator of the special topic, and give directions and deadlines for submissions. If the topic is approved, the applicant(s) will solicit papers and act as guest editor. The JMGS editors will oversee the double blind review process, as per the Journal's submission procedures.

PA 1001.B84). With the 2014 launch of the electronic edition of the Bulletin, the MGSA website will devote a special section to storing current and older electronic copies. The Minutes of the MGSA Executive Board Meetings and Business Meetings from 2013 on will be made available in a password-protected location of the MGSA website, accessible to all current members.

The programs of the MGSA <u>Symposia</u> of the past four decades are easily accessible via the MGSA's homepage.

The MGSA archives reside at the Princeton University Library. They are accessible to researchers who make arrangements with the Department of Rare Books and Special Collections. Some boxes, however, remain closed until a certain time limit has expired.
